INSTRUCTIONS

1. Pursuant to the provisions of Section 110 of the Companies Act, 2013 read with Rule 22 of the Companies (Management and Administration) Rules, 2014, as amended, assent or dissent of the members in respect of the Resolution contained in the Postal Ballot Notice dated 6th August 2015 is being sought through Postal Ballot process.
2. A member desiring to exercise his/her vote by Postal Ballot, may send the duly completed form in the enclosed self addressed postage prepaid envelope. The envelope bears the name of Shri Sandip Kumar Kejriwal, Practicing Company Secretary, appointed as the Scrutiniser by the Board of Directors of the Company.
3. Postage on the envelope is borne by the Company. However, envelopes containing Postal Ballot Form, if sent by courier or by registered post at the expense of the member will also be accepted. The Postal Ballot(s) may also be deposited personally at the Company's Registered Office at 8th Floor, Birla Building, 9/1 R. N. Mukherjee Road, Kolkata - 700 001.
4. The envelope containing the Postal Ballot Form should reach the Scrutiniser not later than **5:00 PM on Sunday, 27th September, 2015**. A Postal Ballot Form received after this date and time will be strictly treated as if the reply from the member has not been received.
5. A member has to convey his/her assent or dissent in the Postal Ballot Form only. Assent or dissent to the proposed resolution may be recorded by placing a tick mark (✓) in the appropriate column. Postal Ballot Form bearing (✓) mark in both the columns will render the Form invalid.
6. In case of joint holding, the Postal Ballot Form should be completed and signed (as per the specimen signature registered with the Company) by the first named Member and in the absence of such Member, by the next named joint-holder. A member may sign the Postal Ballot Form through an attorney; in such case, a certified true copy of the Power of Attorney should be attached to the Postal Ballot Form. There will be only one Postal Ballot Form for every Folio irrespective of the number of joint Member(s).
7. In case of shares held by Companies, Trusts, Societies, AOPs, etc., a duly completed Postal Ballot Form should be signed by its authorized signatory. In such cases the duly completed Postal Ballot Form should also be accompanied by a certified copy of the Board Resolution/Authority together with the specimen signature(s) of the duly authorised signatory(ies).
8. A member neither needs to use all his/her votes nor needs to cast all his/her votes in the same way.
9. An incomplete, unsigned, incorrectly completed, incorrectly ticked, defaced, torn, mutilated, over-written, wrongly signed Postal Ballot Form will be rejected. The Postal Ballot shall not be exercised by a proxy.
10. Notwithstanding anything mentioned elsewhere under these Instructions, a Postal Ballot Form shall be considered invalid if:
 - (a) A form other than one issued by the company has been used;
 - (b) It has not been signed by or on behalf of the Member;
 - (c) Signature on the Postal Ballot Form doesn't match the specimen signatures with the company;
 - (d) It is not possible to determine without any doubt the assent or dissent of the Member;
 - (e) Neither assent nor dissent is mentioned;
 - (f) Any competent authority has given directions in writing to the Company to freeze the Voting Rights of the Member;
 - (g) The envelope containing the Postal Ballot Form is received after the last date prescribed;
 - (h) The Postal Ballot Form, signed in a representative capacity, is not accompanied by a certified copy of the relevant specific authority;
 - (i) It is defaced or mutilated in such a way that its identity as a genuine form cannot be established;
 - (j) Member has made any amendment to the Resolution or imposed any condition while exercising his vote.
11. A Postal Ballot Form which is otherwise complete in all respects and is lodged within the date and time specified in Point No. 4 above but is undated shall be considered valid.
12. The Scrutinizer's decision on the validity of Postal Ballot Form will be final.
13. Voting rights shall be reckoned on the paid up value of shares registered in the name of the **Member as on 21st August 2015**.
14. A member may request for a duplicate Postal Ballot Form, if so required. However, the duly completed duplicate Postal Ballot Form should reach the Scrutiniser not later than the date and time specified in Point No. 4 above.
15. Members are requested not to send any other paper along with the Postal Ballot Form (except those authorised by the Company) in the enclosed self addressed postage prepaid envelope as all Postal Ballot(s) will be sent to the Scrutiniser and any extraneous paper found in such envelope would be destroyed by the Scrutiniser.
16. The Resolution, if assented by requisite majority, shall be considered as passed on **Sunday, 27th September, 2015** (i.e. the last date of receipt of completed Postal Ballot Form and e-Voting).
17. E-Voting : The Company is pleased to provide e-Voting facility as an alternate to all the members of the Company to enable them to cast their votes electronically instead of through physical Postal Ballot. E-Voting is optional. Detailed e-Voting instructions are given under Note No. 17 of the Postal Ballot Notice dated 6th August, 2015. **The e-Voting window is open from 9:00 AM on Saturday, 29th August, 2015 till 5:00 PM on Sunday, 27th September, 2015**. In case a member has voted through e-Voting facility, he does not need to send the physical Postal Ballot Form. In case a member casts his vote through e-Voting facility, as well as, sends his vote through physical Postal Ballot, the vote cast through physical Postal Ballot shall NOT be considered and the voting through e-Voting shall only be considered by the Scrutiniser. Members are requested to refer to the Postal Ballot Notice and Notes thereto, for detailed instructions with respect to electronic voting.
