Brief Summary of the proceedings of the Annual General Meeting

The Annual General Meeting (AGM), of the Members of The Rameshwara Jute Mills Limited convened at 3:00 P.M. on Thursday, 18th September, 2025 at 16th floor, Birla Building, 9/1, R.N Mukherjee Road, Kolkata-700001.

- The Company secretary welcomed all Members and introduced all Directors, KMPs and representatives of the Statutory Auditor and Secretarial Auditor.
- Shri Rajendra Prasad Pansari, Chairman of the Company, chaired the Meeting. Requisite Quorum being present, the Meeting was called to order.
- The Notice convening the Meeting, the Audited Financial Statements for the Financial Year ended 31st March, 2025, Auditor's Report thereon and Directors Report were taken as read by the Chairman.
- Facility for casting votes by remote e-Voting was provided to the Members from Monday, 15th September, 2025 at 9:00 A.M to Wednesday, 17th September, 2025 at 5:00 P.M. through CDSL platform.

The following items of businesses were transacted through remote e-Voting and balloting.

1. To consider and adopt the Audited Financial Statements of the Company for the financial year ended 31st March, 2025 together with the Report of the Board of Directors and Auditors thereon.
2. Re-appointment of Shri Rajendra Prasad Pansari (DIN: 00869222), as Director, who retires from office by rotation, but being eligible, offers himself for re-appointment.
3. Continuation of Shri Rajendra Prasad Pansari (DIN: 00869222), as a Non-Executive Director.
4. Appointment of Secretarial Auditor of the Company.

The Company had appointed Kamal Kumar Sharma, Practicing Company Secretary (PCS No. 4057), Kolkata as the Scrutinizer to scrutinize the e-voting process.
