## Brief Summary of the proceedings of the Annual General Meeting

The Annual General Meeting (AGM), of the Members of The Rameshwara Jute Mills Limited convened at 3:00 P.M. on Thursday, 18<sup>th</sup> September, 2025 at 16<sup>th</sup> floor, Birla Building, 9/1, R.N Mukherjee Road, Kolkata-700001.

- The Company secretary welcomed all Members and introduced all Directors,
   KMPs and representatives of the Statutory Auditor and Secretarial Auditor.
- Shri Rajendra Prasad Pansari, Chairman of the Company, chaired the Meeting. Requisite Quorum being present, the Meeting was called to order.
- The Notice convening the Meeting, the Audited Financial Statements for the Financial Year ended 31<sup>st</sup> March, 2025, Auditor's Report thereon and Directors Report were taken as read by the Chairman.
- Facility for casting votes by remote e-Voting was provided to the Members from Monday, 15<sup>th</sup> September, 2025 at 9:00 A.M to Wednesday, 17<sup>th</sup> September, 2025 at 5:00 P.M. through CDSL platform.

The following items of businesses were transacted through remote e-Voting and balloting.

- To consider and adopt the Audited Financial Statements of the Company for the financial year ended 31<sup>st</sup> March, 2025 together with the Report of the Board of Directors and Auditors thereon.
- 2. Re-appointment of Shri Rajendra Prasad Pansari (DIN: 00869222), as Director, who retires from office by rotation, but being eligible, offers himself for reappointment.
- 3. Continuation of Shri Rajendra Prasad Pansari (DIN: 00869222), as a Non-Executive Director.
- 4. Appointment of Secretarial Auditor of the Company.

The Company had appointed Kamal Kumar Sharma, Practicing Company Secretary (PCS No. 4057), Kolkata as the Scrutinizer to scrutinize the e-voting process.
